

Terms of Use — Petggle

These Terms of Use (“**Terms**”) govern your access to and use of the Petggle website, content, and features (the “**Site**”). By using the Site, you agree to these Terms. If you do not agree, please do not use the Site.

1. Who we are & how to contact us

3. Your responsibilities

You agree to:
